



1.USB "A" Port

The FINAL USB type "A" port is for the USB cable coming from the computer or iFi iUSB Power.

Tip: For optimal performance, we recommend the iFi Mercury or Gemini USB cables.

2.USB "B" Connector

The Final USB type "B" connector please insert into the type B signal input port of the DAC.

3.LED

With green LED lit, audio+power are successfully passing through.

Tip: The iPurifier is most effective at the "end of the digital signal chain". Hence should be placed USB cable > iPurifier > DAC. That is, in the USB "B" port of the DAC. The iPurifier performs the following functions to maximise USB audio playback quality:

- (i) Cleans up the USB data lines*
- (ii) Cleans up the USB power lines**
- (iii) Performs data line re-balancing*
- (iv) Remove harmful DC offset*

So after the iPurifier, one will have a higher level of USB audio playback.

**To attain the very highest quality of USB power, we recommend you use the iPurifier in conjunction with the iFi iUSB Power. Although the iPurifier will filter out noise on the USB Bus Power, the iFi iUSB Power regenerates a completely new and independent clean power supply (even cleaner than battery power) for USB audio playback.*
